Built on the Solana blockchain, \$PROP offers investors and traders a transparent, secure, and scalable entry point into the ecosystem of Financia Futures, a legitimate and operational proprietary trading firm. With clear tokenomics, instant token delivery, and a no-nonsense approach to liquidity, PROP aims to bring long-term value through utility, community participation, and strategic growth.

PROP serves as the foundation of a growing digital ecosystem anchored by a real business model. Unlike speculative tokens with unclear backing or vague promises, PROP is purpose-built to enhance and expand the Financia Futures platform, supporting initiatives such as staking, trading rewards, and exclusive access for token holders.

PROP is launching on <u>Solsale.app</u>, with its first decentralized exchange listing on Raydium. Future exchange listings will be driven by organic demand and long-term strategy rather than artificial hype.

Backed by <u>Financia Futures</u>, a global proprietary trading firm that funds real traders and supports genuine financial growth, PROP stands apart with a transparent roadmap and a commitment to sustainable utility. The token will eventually serve as the key to platform benefits, staking rewards, and further innovation across both traditional and decentralized finance.



## **The Problem**

Despite the growth of financial markets and retail trading platforms, access to meaningful trading capital remains a significant barrier for most aspiring traders. Traditional prop firms often implement complex evaluation processes, hidden rules, or aggressive profit splits that create more friction than opportunity. The average trader is left navigating a maze of restrictions, capital requirements, and inconsistent funding models that limit their ability to grow.



In the broader blockchain and token ecosystem, similar challenges persist. Many projects claim to support traders or financial empowerment but lack real-world integration or practical utility. Prop trading tokens, when they exist, are often unbacked by functioning businesses, rely on inflationary tokenomics, or fail to provide transparency around how funds are used or how rewards are distributed. This disconnect creates skepticism and deters serious participants.

Compounding the issue is a growing trust deficit. Investors and community members are frequently misled by unclear roadmaps, unverifiable claims, or unsustainable reward systems that collapse over time. Tokens may rise in initial value only to crash due to poor liquidity management, unchecked minting, or the absence of real economic backing. Without transparency, long-term sustainability, or genuine use cases, confidence erodes, and with it, the value of the token and the community.

# The Solution: PROP Token

PROP addresses long-standing issues in both prop trading and crypto ecosystems by offering a utility token that is backed by a real, operating proprietary trading firm — Financia Futures — and built with transparent, fixed tokenomics on the Solana blockchain.

#### Real Utility Backed by a Trading Firm

Unlike speculative tokens with no real-world link, \$PROP is anchored to Financia Futures, a functioning proprietary trading business. This backing provides immediate context, relevance, and use case. It ensures that the token value isn't just driven by hype, but by real trading activity and platform integration.

#### **Transparent Access and Distribution**

PROP removes the barriers that prevent everyday traders from benefiting from token ecosystems. The presale is hosted on <u>Solsale.app</u> using audited smart contracts, offering instant token delivery, no lockups, and a hard cap of 1,000 SOL. The rate is clearly defined, 480,000 PROP per 1 SOL in presale, with DEX listing at 400,000 PROP per 1 SOL. There are no surprise allocations, and any unsold tokens are automatically burned, not redistributed or held.

## O3 Trust Through On-Chain Safeguards

Trust is reinforced through measures that can be verified on-chain. 80% of raised funds will be permanently burned as liquidity, and the contract has no mint function, ensuring a capped supply and resistance to inflationary manipulation. Token holders aren't asked to trust words — they can trust the code.

## O4 A Foundation for Future Utility

While staking and rewards are planned for future releases, the foundation is already in place for long-term participation. As the Financia Futures ecosystem expands, \$PROP will evolve with it, but from day one, it is already designed with **purpose, security, and transparency** in mind.

As the platform grows, PROP will become a bridge between the firm's real-world trading performance and its digital token economy, laying the groundwork for future innovation in both finance and crypto.


# **Token Utility**


